It has been a busy couple of months for the executive committee. Some of our officers attended workshops put on by NYSUT at our regional office. They offered a workshop for treasurers to let them know of any new updates on forms to send to IRS, what you should or should not add to the account with dues money, and what NYSUT offers to help local's and their finances. There was also one for our Vote Cope chair as well as some on engaging members, the constitutional convention and what could happen if that were to get passed and a few others.

Save your sick time

There are many reasons why you want to save your sick time.

If you get hurt outside of work or need surgery, you need those sick days to get you through until you are good to go back to work. You may have purchased disability insurance to help with that. As state employees we do **not** automatically get disability insurance.

If you get hurt at work, you do get worker's compensa-

tion refer to page 14 in your contract for language on that. However there is a period of time until it gets approved. If you are out on comp and do not have sick leave, you may have to pay full amount of your health insurance.

Then if you look in the contract on page 20 you get compensation for the accumulated sick days that you did not use upon retirement. You have to have 20 years service. So please take a few

minutes and read that section in your contract.

It is really a good idea to become familiar with your contract. Yes, it is your contract. This current contract is good through June 30, 2017.



Family Medical Leave Act

BOCES is sending out an FMLA packet when someone has been out for three sick. This is concerning to some of those who have received these packets. We just want to assure you that it is not an immediate problem unless you are out of

sick time. None of what is in the packet will take effect until your sick days are all used.

NYS has also approved twelve paid weeks of FMLA leave. Before you get too excited this is a contractual issue that will need to be dealt with in the next contract negotiations.

BOCES is required to send you this packet within 5 days of your being out sick for 3 days.

Know Your Contract

On page 12 of the contract at the bottom of the page it deals with Bereavement Leave. It says the following.

Up to three days with pay will be allowed for each death in the immediate family upon approval of the Director of Human Resources.

The immediate family shall include spouse, children, and members of the same household, father and mother, brothers, sisters, grandmother and grandfather, grandchildren, comparable relatives of the unit member's spouse.



Bereavement leave in no way affects sick leave or personal leave A Union of Professionals and is not accumulative.

Clothing Allowance

On page 25 in the contract it addresses clothing allowance. These job titles assigned to buildings and grounds, shall receive \$125 per year allowance for clothing/shoes: Cleaner, School Chauffer, Custodian, Laborer, Messenger, Building Maintenance Assistant, Building Maintenance Mechanic, Carpenter, Senior Building Maintenance Mechanic, and HVAC Services Engineer.

If you are one of these people, make sure you use it before the end of the school year. Don't let it pass by without taking advantage.
